 - Mr. Baza informed the Commission the Imperial County Transportation Commission received a presentation regarding the U.S. Census Bureau 2021 – Imperial County Data Summit & Community data on July 14, 2021 at the Management Committee meeting. It was announced that many Cities had a double digit increase in response for the Imperial Valley cities, with more than a 4% increase compared to 2010.  - Ms. Mendoza provided updates on the Regional Active Transportation Plan stating ICTC staff kicked off this project in April 2021 and has conducted two (2) Techincal Advisory Committee meetings with City, County, SCAG, and Caltrans staff to start data gathering and early outreach efforts. The KTUA consultant team and ICTC staff recently hosted a series of outreach u events starting in July to receive input from the

community, a series of events are scheduled to be held in August. A dedicated project page has been developed for the project and can be found at <u>https://ictcatp-ktuagis.hub.arcgis.com/</u>. ICTC is also encouraging the community to participate in the online survey at https://www.surveymonkey.com/r/ictcatp

- Ms. Mendoza stated the Imperial County Draft Regional Climate Action Plan is posted on the ICTC website at <u>http://www.imperialctc.org/regional-climate-action-plan/</u>. A final draft Regional CAP has been presented to some city councils as an information item during the month of June 2021. The final draft Regional CAP was presented to the ICTC Technical Advisory Committee on May 27, 2021, and ICTC Management Committee on June 9, 2021.The plan has also been presented to the Coalition of Labor, Agriculture and Business (COLAB) on June 9, 2021; the Imperial Valley Vegetable Growers Association (IVVGA) on June 16, 2021; the Imperial County Farm Bureau on June 17, 2021. The Regional CAP was presented to the ICTC Commission on June 23, 2021.
- Mr. Baza stated ICTC staff is currently completing the Caltrans award review process with multiple Caltrans' departments. The ICTC Board adopted the agreement with Psomas on September 26, 2018. Environmental phase has been completed. Design is underway and Right of Way Acquisition is underway is Summer 2021.

A. Calexico East Port of Entry Bridge Expansion Project – Construction Management/Resident Engineering Contract Award

Mr. Aguirre informed the committee the U.S. Department of Transportation awarded the Imperial County Transportation Commission Committee (ICTC) with a 2018 Better

Utilizing Investment to Leverage Development (BUILD) grant in the amount of \$20 million for the Calexico East Port of Entry Bridge Expansion project.

The procurement process consisted of a single phased Request for Proposals (RFP) approach. The RFP was released April 5, 2021, four (4) firms responded to the RFP. An evaluation team comprised from representatives from Caltrans, General Services Administration (GSA), Imperial Irrigation District (IID) and ICTC participated in the evaluation of the proposals. The Evaluation team unanimously ranked Jacobs as the highest-ranking firm. ICTC proceeded to request a formal cost estimate to complete the required services. Jacobs submitted the proposed cost of \$2,956,457.81.

Jacobs has extensive experience working with similar type bridge improvement projects. The Jacobs team is well qualified and will be able to assist ICTC with the various management/resident engineering tasks. Jacobs will utilize the services of a DBE located in the Imperial Valley area to assist with various required services.

Funding for the construction management/resident engineering services was identified and approved in the ICTC FY 2021-22 OWP and budget. The funding source will be a combination of the awarded federal (BUILD), TCEP, and local funds.

B. Calexico Intermodal Transportation Center (ITC) Architectural and Engineering Services – Change Order – Contract Amendment #2

Mr. Aguirre announced ICTC awarded the contract to Psomas, to assist with the development of the project improvement plans, specifications, contract documents and

some environmental documentation required to complete the preliminary engineering for the Calexico ITC Project.

The initial agreement was approved by the commission in the amount of \$557,884.63. A change order was previously approved in the amount of \$63,437.00 to complete numerous required environmental studies. The proposed changed order submitted by Psomas is \$62,288.48. ICTC reviewed the proposed scope and fee and found the proposed cost to be reasonable. The total revised contract would be \$683,610.11. The proposed change order – contract amendment fee has been budged in the ICTC FY 21-22 Budget.

The following is a summary of the Executive Director's Report for the ICTC Commission Meeting on September 29, 2021.

- 1) Senate Bill (SB) 619 (Laird D) Organic waste: reduction regulations: local jurisdiction compliance. Current law requires the State Air Resources Board to complete, approve, and implement a comprehensive strategy to reduce emissions of short-lived climate pollutants in the state to achieve, among other things, a reduction in the statewide emissions of methane by 40%. Current law requires the methane emissions reduction goals to include specified targets to reduce the landfill disposal of organics. Current law requires the Department of Resources Recycling and Recovery, in consultation with the state board, to adopt regulations to achieve those targets for reducing organic waste in landfills, and authorizes those regulations to require local jurisdictions to impose penalties on generators for noncompliance, and to include penalties to be imposed by the department for noncompliance. This bill would authorize a local jurisdiction facing continuing violations that commence during the 2022 calendar year of those regulations to submit to the department no later than March 1, 2022, a notification of intent to comply, as prescribed.
- 2) Regional Active Transportation Plan: Imperial County Transportation Commission is undertaking a Regional Active Transportation Plan (ATP) to improve access, mobility, and safety for non-motorized modes of travel, including walking, bicycling, and riding trans it. The Regional ATP is grant funded by the Southern California Association of Governments (SCAG). ICTC staff kicked off this project in April 2021 and has conducted two (2) Technical Advisory Committee meetings with City, County, SCAG, and Caltrans staff to start data gathering and early outreach efforts. A dedicated project page has been developed for the project: https://ictcatp-ktuagis.hub.arcgis.com/

The KTUA consultant team and ICTC staff recently completed a total of 10 Community Outreach Events during the month of July and August to receive input from the community:

- July: Brawley Public Library, El Centro Aquatic Center, and Sunbeam Lake
- August: Salton Sea Public Library, Calipatria Public Library, Holtville Public Library, City of Imperial Library and Movie Pool Event, Westmorland Pool Day, Calexico Public Library, Imperial Valley College Student Welcome Event.

To date we have received over 200 surveys, primarily from the outreach events. We are also encouraging the community to participate in the online survey that will be available until November 2021:

The 4th Project Technical Advisory Committee (TAC) meeting was held on September 8, 2021 to discuss the summer outreach and next steps. The ICTC and Consultant team will review the next steps of deliverables which include draft recommendations, prioritization of projects and planning for four (4) public workshops during the months of October and November 2021.

- 3) Imperial Mexicali Binational Alliance Meeting: An IMBA meeting was held on September 9, 2021 at 9:30am. The meeting was in-person and via zoom at CETYS University in the City of Mexicali at Sala Gulfstream. The meeting included presentations from CETYS University, AB 617 presentation by the Imperial County Air Pollution Control District, Tree Planting Program presentation by the Mexicali Economic Development Commission, and Border Infrastructure and Economic Development updates.
- 4) Calexico East Port of Entry Bridge Widening Project: The Project proposes to widen the bridge over the All-American Canal at the U.S./Mexico border approximately 0.7 miles south of State Route (SR) 7. The project proposes to widen the existing structure by adding four-lanes: Two New Northbound Auto Lanes and Two New Northbound Commercial Vehicle Lanes. In May 2018, Caltrans and ICTC received \$3,000,000 from the California Transportation Commission and the Trade Corridor Enhancement Program (TCEP) to complete the Project Approval and Environmental Document (PA/ED) for the project. In June 2018, Caltrans completed a Project Initiation Document (PID). In Fall of 2018, the PA/ED phase was initiated by Caltrans, technical studies for the National Environment Policy Act (NEPA) document under Caltrans as the NEPA lead are in progress and is scheduled for completion in May 2020. In December 2018, was awarded \$20 million under the U.S. Department of Transportation's BUILD discretionary grant program to complete the Design-Build construction phase. *ICTC staff completed the procurement process and award action was taken on March 24, 2021. Design phase is underway. ICTC has recently advertised a Request for Proposals for Construction Management services to provide engineering support on behalf of ICTC through design and construction. Proposals were due on May 21, 2021. After review and selection process, the ICTC Board approved the award to Jacobs company.*
- 5) State Route 86 (Northbound) Border Patrol Checkpoint: State Route 86 (Northbound) Border Patrol Checkpoint: In August 2017 following a year of coordination, Caltrans, the County of Imperial and ICTC met with CBP management and operations staff achieved consensus for a new conceptual alternative prepared by Caltrans. The LTA Board met on September 27, 2017, staff presented the Board with a fund request for \$1.3 million from the 5% Regional Highway Set-Aside from the Measure D allocations. A Consultant Agreement with AECOM for design and construction engineering was approved by the LTA on February 28, 2018. Following our ICTC Board meeting in late September 2020, ICTC has initiated a traffic study as required by Caltrans. Design work has been delayed due to Border Patrol's concern related to their ability to provide additional funding necessary to meet their operational requirements. Discussions have been on-going through to this week of March 15, 2021. On Wednesday, March 17th ICTC received confirmation from Border Patrol Headquarters in Washington D.C. that they wish to proceed with the original Canopy Design that is similar to Interstate 8 Pine Valley Checkpoint.

As discussed and confirmed with Border Patrol, ICTC will only provide the remaining funds we had available (February 2021) of approximately \$1 million to complete the traffic study, 100% design plans, and construction of the canopy, lighting related to the canopy, and traffic related improvements required by Caltrans. Border Patrol has committed paying for all other construction related costs and Border Patrol will lead the construction contract. *Border Patrol, Caltrans and ICTC are having weekly meetings toward completing design plans and Caltrans Permits with a goal to begin construction in Fall 2021 with construction completed in approximately six months after construction begins.*

6) **Calexico Intermodal Transportation Center (ITC):** A new Intermodal Transportation Center in the City of Calexico has been part of ICTC's long range transit planning. The new Calexico ITC will serve as a regional mobility hub that will accommodate bus bays for Imperial Valley Transit in addition to the City of Calexico's private transit operators, taxis and farm labor buses. ICTC received a Congestion Mitigation and Air Quality federal program fund to complete the environmental and design plans of the new Calexico ITC. ICTC staff is in

the process of completing the contract award for a consultant firm that will complete the environmental and design phase. Currently, ICTC staff is completing the Caltrans award review process with multiple Caltrans' departments. The ICTC Board adopted the agreement with Psomas on September 26, 2018. *Environmental phase has been completed. Design and Right of Way Acquisition is underway and is expected to be completed in December 2021. ICTC is exploring funding opportunities for \$12.5 million needed for construction.*

- 7) I-8 / Imperial Avenue Interchange Reconstruction: Caltrans and construction team have been meeting with City of El Centro and ICTC to discuss details of construction phases and the public information campaign for both the Interchange Project and the Imperial Avenue Extension South Project. Stage 1 of construction began on Monday, May 6, 2020. During the extended closure, motorists on eastbound I-8 will be detoured along 4th Street/State Route 86 (SR-86) located east of Imperial Avenue. On July 23rd closure of the I-8 was needed to demolish and remove the existing bridge. Crews have completed the demolition of the existing bridge at the I-8/Imperial Avenue Interchange. There were no reported incidents and detoured traffic was flowing with no major delays. Over the next month, the community will see crews performing general earthwork operations. There will be construction equipment, nose (including OSHA required backup alarms), dust and some minor traffic control. Stage 2 work on the northern portion of I-8 is anticipated to take four to six months to complete and could begin as early as December. During Stage 2, all I-8/Imperial Avenue on- and off- ramps will be fully closed. *The bridge deck pour was completed the night of August 25, 2021. The interchange is expected to open to traffic by the end of 2021 with project completion in 2022.*
- 8) State Route 98 Widening from Ollie to Rockwood: As part of the Calexico West POE Expansion project, SR-98 and Cesar Chavez Boulevard were widened and improved to serve the expansion to the west. Caltrans' SR-98 work between VV Williams and Ollie Avenue was completed in March 2018, and the Cesar Chavez Blvd. Widening was completed in October 2019. Caltrans has completed the design and right of way phase for SR-98 Widening between Rockwood Avenue and Ollie Avenue. On June 24, 2020, CTC authorized construction funding. The total project cost is estimated at \$7 million using a combination of 2016 Earmark Repurposing, Demonstration, Traffic Congestion Relief, ICTC and local funds. *The construction start date was delayed to due to environmental impacts and other utility projects in progress within the project area. Construction of the project has begun on August 6, 2021.*
- 9) US Census 2020: The Imperial County Transportation Commission received a presentation from the U.S. Census Bureau regarding the <u>U.S. Census Bureau 2021 – Imperial County Data Summit & Community data on July 14</u>, 2021 at the Management Committee meeting. It was announced that many cities had a double digit increase in response for Imperial Valley cities, with more than a 4% increase compared to 2010.

The Census Bureau held their first kickoff workshop on July 14, 2021, hosted by the Census Legacies table, the U.S. Census Bureau, and the center for Social Innovation at UC Riverside. The purpose of the workshop was to empower community members through a series of live demonstrations and training on how to easily access the U.S Census data and tools directly on their official websites. The event was also an opportunity to establish a partnership with local U.S Census Bureau representatives that can answer questions, provide resources, as well as hear community feedback and ideas. The next event with a total of five workshops is set to be on held on July 30, 2021, at 4:00 p.m. The goal is to promote Regional Equity, targeting the input of the youth department.

10) **Potential Bus Stop in Calipatria:** ICTC has evaluated all of its fixed route service routes to attempt to provide service to the east side of Calipatria. Staff conducted time trials as well utilized several types of buses to verify buses would not have issues with other existing stops within proposed routes. Potential stops for the area include a stop along Commercial Avenue and potentially another stop near Alexandria Street. Staff is proposing to utilize its IVC Express route to potentially service the area. ICTC and City staff have begun coordination to implement final location and infrastructure associated with the potential bus stop(s).

- 11) Imperial County Regional Climate Action Plan: After the kick-off meeting on June 28, 2019, ICTC established Project Management Procedures and Communication Protocols with the Consultant as well as reviewing the Scope of Work and Schedule. The consultant is working on the draft Climate Action Plan (CAP) and finalizing the inventory, forecasts, and targets; anticipating a Final Draft of the CAP by Mid-March, 2021. ICTC member agencies' will have the opportunity to review the Final Draft CAP with a goal of having comments back by March 31, 2021. As we move forward with public comments, ICTC will post the CAP on their website with the intent to get feedback and comments from the public. The Draft Regional CAP is posted in the ICTC website at http://www.imperialctc.org/regional-climate-action-plan/. The public review period took place April 6, 2021 to May 10, 2021. A final draft CAP has been presented to some city councils as an information item during the month of June 2021. The final draft Regional CAP was presented to the ICTC Technical Advisory Committee on May 27, 2021 and ICTC Management Committee on June 9, 2021; the Imperial Valley Vegetable Growers Association (IVVGA) on June 16, 2021; and the Imperial County Farm Bureau on June 17, 2021. The Regional CAP was presented to the ICTC Commission on June 23, 2021.
- 12) Imperial Valley Transit (IVT) FREE FARES PROGRAM: On August 7, 2020, the Imperial County Transportation Commission (ICTC) announced the implementation of a Free Fares Program for various Imperial Valley Transit (IVT) services. Eligible services include IVT Fixed Route, IVT Circulators (Blue, Green and Gold Lines), IVT ACCESS and IVT RIDE (EL Centro, Imperial, Heber, Brawley, Calexico, Westshores). All passengers are eligible to benefit from the Free Fares Program. The fares are subsidized by a State of California grant and fare contributions to IVT RIDE passengers by the County of Imperial's Area Agency for the Aging (AAA). The Free Fares Program will remain in effect while the grant funds are available. All regular service eligibility requirements and restrictions remain in effect.
- 13) **Funding for Phase II of the Calexico West Port of Entry**: As previously noted, Congress authorized \$98 million for Phase 1. The U.S. General Services Administration (GSA) began construction for Phase 1 in December 2015 with completion now scheduled for July 2018. Phase 2A was awarded in the amount of \$191million and will include six additional northbound privately-owned vehicle (POV) inspection lanes, permanent southbound POV inspection, expanded secondary inspection and adding a pre-primary canopy, new administration building, and employee parking structure. *Funding for phase 2B is in the President's Budget Proposal in the amount of \$99.7million. Work for phase 2B will include demolition of the old port building and construction of the new pedestrian building. The total estimated cost for phases 2A plus 2B are \$276million. According to GSA Phase 2A is anticipated to be completed Spring 2023.*
- 14) **State and Federal Local funding Obligations:** Projects programmed in programmed in Federal Fiscal Year (FFY) 2019/2020 were fully obligated according to Caltrans Local Assistance. Beginning October 1, 2020, agencies can move forward with request for authorization (RFA) for Congestion Mitigation Air Quality (CMAQ), Surface Transportation Block Grant program (STBG) programmed in FFY 2020/2021. Other state funding also included in the Federal Transportation Improvement Program (FTIP) include the Active Transportation Program (ATP). *See complete project list attached.*
- 15) **2018 Trade Corridor Enhancement Program:** The Trade Corridor Enhancement Program (TCEP), created by Senate Bill (SB) 1 (Beall, Chapter 5, Statutes of 2017), provides approximately \$300 million annually for infrastructure improvements on federally designated Trade Corridors of National and Regional Significance, on the Primary Freight Network, and along other corridors that have a high volume of freight movement. ICTC in partnership with Caltrans and the San Diego Association of Governments (SANDAG) were successful in receiving TCEP funds for Advanced Technology Corridors at the California-Mexico Ports of Entry (POE). The goal project is to implement Intelligent Transportation System (ITS) strategies that will improve border travel delays. Some of the ITS strategies will include Bluetooth and Wi-Fi readers to help track vehicle delays, as well as implement changeable message signs on State Routes to inform border travelers of POE delays. Caltrans will serve as the implementing agency of this project and has an estimated completion date of early 2020. *Caltrans has initiated the environmental phase and preliminary design of the project. TCEP funds will be used in collaboration with the BUILD grant award for the design and construction phases. ICTC is making a request for*

allocation from the California Transportation Commission (CTC) for the \$7.5 million for design and construction at their June 23, 2021 meeting.

16) State Legislation for Transportation Funding – SB 1 Road Maintenance and Rehabilitation Account (RMRA): \$1.5 Billion annually will go to cities and counties for local road improvements. The following are projected annual revenues of RMRA for the FY 20/21. This list of projects for all cities and the county can also be found on the ICTC website at: <u>http://www.imperialctc.org/senate-bill-1/</u>

17) **California-Baja California Binational Region:** A Fresh Look at Impacts of Border Delays: Building upon previous Caltrans, SANDAG, and ICTC studies, this project will refine the economic models developed to assess economic impacts of delays at the land ports of entry (POEs) between the San Diego and Imperial Counties region and Baja California, Mexico, on the border region economies. It will also estimate greenhouse gas (GHG) emissions of passenger and commercial vehicles due to northbound and southbound border delays at the six California POEs and propose strategies to reduce GHG emissions at the border region. Lastly, extensive outreach to government agencies, local border communities, and private sector stakeholders was conducted.

18) State Legislation for Transportation Funding – SB 1 2018 Local Partnership Program (LPP): Local Partnership Program is comprised of formulaic program and competitive programs. In FY2017/2018 total amount available statewide is \$200M and distribution is 50/50 for both formulaic and competitive programs. The formulaic program share distributions for the Local Partnership Program were presented at the CTC meeting in December 6-7, 2017. The Imperial County received \$1,632 of Local Partnership Formulaic Program (LPFP) funds in Cycle 1 (\$1,076) and Cycle 2 (\$556) for a total of \$1,632.

19) **Partnerships with IVEDC:**

a) Southern Border Broadband Consortium (SBBC): For FY 2020/2021, SBBC continues to work with local stakeholders to identify, prioritize and advance broadband infrastructure and improvement projects; facilitate and promote broadband education community wide using survey data; work with the Boys and Girls Club of IV and the Workforce Development Board to create Digital Literacy Centers throughout Imperial County; and develop a preferred scenario for 98% deployment in Imperial County and present to the California Advanced Service Fund and the CPUC. Recent updates to SBBC's role in the region include a partnership with local healthcare organizations including ECRMC, Pioneers Hospital and Alliance Healthcare to identify telemedicine broadband needs and funding opportunities in Imperial County; working with the California Emerging Technology Fund and the Inland Empire Regional Broadband Consortium as part of a SCAG project to identify transportation broadband strategies to reduce VMT and greenhouse emissions; and working with local internet services providers including AT&T to assist successful applications for funding opportunities with the CPUC in locations such as north County, central Imperial and the Imperial Business Park by end of July 2020. SBBC completed the objectives of the 2017-2020 CPUC CASF Consortia Grant cycle, which ended in June 2020. SBBC applied for a second grant cycle in summer of 2020 and was approved in the Fall for a start date of December 1, 2020. This cycle will have bi-annual reporting, every 6 months, starting this upcoming May 31, 2021 through the end of the cycle, November 31, 2023. The 2020-2023 grant cycle is currently underway. We are getting ready for the first report of the cycle, due at the end of May. SBBC is also working on the final reporting for the previous cycle and subsequent payment from CPUC with the help of CPA, Roger Tubach and our contacts at CASF.

As of September 02, 2021 a total of \$109,369.48 have been submitted and approved for reimbursement. The remaining grant balance is \$340,630.52 out of the original \$450,000 grant award.

- b) <u>The Brawley Transit Corridor Brownfield Assessment:</u> ICTC in partnership with IVEDC received a U.S. Environmental Protection Agency (EPA) Brownfields Communitywide Assessment Grant award of \$300,000 from the Environmental Protection Agency's Brownfields Assessment Program. This assessment is focused along the transit circulator route within the 13-mile Imperial Valley Transit's (IVTs) Brawley Gold Line Transit Route and the Brawley Transit Center that serves as the IVTs North Imperial County transfer terminal. The commercial corridors in the target assessment area include over 100 known commercial properties and suspected historical gas station sites with known or suspected underground tanks in the target area. ICTC is the fiscal agent and has developed an MOU which will define roles and responsibilities (Audits, Administration and Project Management) of ICTC and IVEDC. SCS Engineers Tasks include the Quality Assurance Project Plan (QAPP) and project management plan as required by EPA.
 - (1) The Finnell Property has 3 parcels. Phase 1 and Phase 2 reports have been finalized and 3 underground storage tanks have been excavated and disposed of. Currently assisting the property owner in identifying grant dollars to apply to the site cleanup that is being required after uncovering significant contamination.
 - (2) The Chai Property has 2 parcels. It received DTSC approval on March 28, 2019. Phase 1 report completion occurred on October 15, 2019 and no further action is required. Completed and closed out.
 - (3) The Lesicka Property has 2 parcels. It received DTSC approval on August 29, 2019 and Phase 1 and Phase 2 reports have been finalized and no further action is required. Completed and closed out.
 - (4) The Dek Property has 1 parcel. It received DTSC approval on April 22, 2020. Phase 1 was improperly completed by a previous engineering firm. 95% of the re-development was completed when the contractor discovered concerning amounts of underground contamination on site. We stepped in and completed a phase 2 and we are currently assessing the situation while collecting additional soil samples and pending laboratory results. With our guidance on where to relocate the project's retention basin they were able to complete construction and open the business in early 2021. Completed and closed out.
 - (5) The Pioneers Property has 3 parcels. It received DTSC approval on May 11, 2020. Phase 1's were completed on all parcels. 1 parcel which is the site of a former Chevron station closed on 1975 will require a phase 2. The Field Sampling Plan is currently under review for approval with the EPA staff. Approvals of this nature have been significantly stalled due to COVID. We expect resolution by mid May.
 - (6) The Gibson property received DTSC approval on April 28, 2021. This is a former fueling station and will likely have a recommended Phase 2 site assessment.
 - (7) We are working on a new potential site being considered for redevelopment by a company who wishes to develop a manufacturing facility on the north end of the City of Brawley. We are currently negotiating with the land owner and the developer for inclusion into the brownfield program.

As of September 02, 2021, there is a remaining grant balance of \$112,339. Of the \$112,339, \$106,074 is the remaining contract balance for SCS Engineers.

Of the many noteworthy appropriations, we appreciate the inclusion and funding of the following items:

- Sec. 10: \$50 million for urban greening and urban forestry projects;
- Sec. 15: \$10 million for regional climate assistance, and \$115 million for the Transformative Climate Communities program through the Strategic Growth Council;
- Sec. 16: \$25 million to the Governor's Office of Planning and Research through the Integrated Climate Adaptation and Resiliency Program (ICARP) for climate resiliency planning and implementation grants;
- Sec. 45: \$100 million to CalFire, including for priority urban forestry projects;
- Sec 54: \$25 million in fiscal year 2022-23, and \$75 million in fiscal year 2023-24, to the Governor's Office of Planning and Research for projects that mitigate the impacts of extreme heat or the urban heat island effect;

The following is a summary of the SCAG Executive Director's Report and/or Federal and State Legislature Staff Report for the Imperial County Transportation Commission's Management Committee meeting for the month of September 2021.

- 1. 12th Annual Southern California Economic Summit: From Inclusive Recovery to Inclusive Growth! Save the Date December 2nd, 2021. On Thursday, Dec. 2, SCAG will be hosting the 12th annual Southern California Economic Summit. Unfortunately, due to health and safety concerns regarding COVID-19 the summit will be held virtually again this year. This summit will come at a time when the regional economy is still recovering from a time of unprecedented crisis. Save the date to join civic and business leaders from across Southern California for this vital conversation on how we can further our economic recovery and build strength and resilience in a post-COVID world. The event will be free for elected officials and city managers in the region. Additional information and a link to register will be available soon.
- 2. SCAG Communities of Concern (CoC) Policy Committee Appointment: As part of the 2020 SCAG General Assembly the SCAG bylaws were amended to allow the 7 County Regional Council (RC) representatives an opportunity to appoint one local elected official from SCAG member jurisdictions to a SCAG Policy Committee. SCAG RC member and Imperial County Supervisor Luis Plancarte recently appointed Brawley City Council Member Ramon Castro to be the Imperial County CoC representative. Councilmember Castro will serve on a Policy Committee beginning in October. The appointment is a two-year term, and we look forward to increased engagement and participation from Imperial County representatives.
- **3.** SCAG Regional Data Platform (RDP): The Regional Data Platform will standardize regionally significant datasets, provide opportunities for local partners to update their data in real-time, and draw insights from local trends. More specifically, it will be an online tool for SCAG and local jurisdictions to access data necessary for local general plan development and general decision making by monitoring transportation, land development trends, housing and economic growth, and sustainability conditions. The platform will also feature a data-driven collaboration hub for local jurisdictions to

engage with stakeholders for individual projects, such as local and regional land use planning, active transportation planning, greenhouse gas reduction strategies and development impact assessments.

Moving beyond just technology, this platform will help government engage with data in a simpler way, allowing the interpretation of information into actionable insights and knowledge, and provide a digital venue for local agencies to engage with their residents using data as a medium.

Process wise, SCAG will enable users to improve the platform through data revision and insight sharing, empower local partners to use the platform for their own initiatives (thereby spotlighting best practices), and ultimately foster continuous experimentation at the local level by helping jurisdictions

understand how their plans could impact the region's most significant challenges – transportation, jobs, housing, and sustainability.

- Housing Element Parcel Tool (HELPR): The HELPR tool is a readily available mapping and data tool available to SCAG member agencies and partners. The tool drills down on parcel specific data and demographics which will support the development of housing plans and general plan updates.
- Local Information Services Team (LIST): SCAG has created the "Local Information Services Team" to support the roll out of the Regional Data Platform (RDP) and other housing and data support needs.
- 4. SCAG and UC Davis: COVID-19 Mobility Study Survey: To better understand the impact of the COVID-19 pandemic on mobility in the six-county region, SCAG partnered with University of California, Davis to launch a survey to investigate the evolving nature of the impacts of the pandemic on transportation in the SCAG region. The survey is part of an on-going investigation on the impacts of the COVID-19 pandemic on transportation and society, to understand how people are adjusting to the pandemic and to learn more about their attitudes towards future travel choices. The survey seeks to understand both the temporary and long-lasting changes that the COVID-19 pandemic may have on mobility in their region, and how various policies might affect this new "normal" in terms of modified travel behaviors and resulting impacts on equity and on the environment. SCAG will be conducting another round of surveys to further advise the study. Please take the opportunity to complete the survey once released. Please contact SCAG RAO David Salgado with any questions.
- **5. SCAG Broadband Action Plan:** At the February 4th SCAG Regional Council (RC) Meeting, the SCAG RC adopted a resolution which directs SCAG staff to develop a "Broadband Action Plan." The development of an action plan would provide a model resolution and policy paper for local jurisdictions, pursue funding opportunities and partnerships to assist local jurisdictions with broadband implementation, convene a working group, and further support broadband planning and data research. These efforts would also be developed to compliment SCAG's ongoing efforts to support an Inclusive Economic Recovery and efforts supporting Racial Equity and Social Justice.

6. SCAG Aerial Imagery Project 2020-21 Update: The flyovers have been completed and an introductory meeting was held with the vendor, EagleView. The meeting was offered to member jurisdictions and stakeholders to introduce some of the new products provided as a part of the project, which includes high resolution imagery, ortho imagery and other products. SCAG is working with the county to finalize an MOU prior to requesting local contributions for supporting the program.

SOCAL GREENPRINT PUBLIC HEARING HELD

On Aug. 24, SCAG hosted a public hearing on the <u>SoCal Greenprint</u>, a web-based tool that will compile more than 100 existing data sources into interactive maps to help stakeholders visualize how to better integrate nature into future growth and development. The public hearing was held at the direction of the Regional Council, which voted at the July 1 meeting to pause the implementation of the SoCal Green print for at least 30 days and hold a public hearing.

The public hearing included an introduction by SCAG President Clint Lorimore and an overview presentation from SCAG staff. Over 75 stakeholders participated in the public hearing and 33 stakeholders provided verbal comments. SCAG also received 36 written comments before the 6:00 p.m. deadline. A video of the public hearing, the presentation, and written comments are all available for review on the <u>Public Hearing & Comments webpage</u> on the SCAG website. The written comments and feedback received during the public hearing will be summarized for the Regional Council, as will input received from other outreach activities and survey findings on the SoCal Greenprint's proposed data layer list.

In addition to the public hearing held on August 24, another public hearing will be held in the future to provide an opportunity to share comments and feedback directly with the Regional Council.

SCAG RECEIVES STATE BUDGET EARMARK FOR IERS IMPLEMENTATION

At its July 1 meeting, the Regional Council adopted the <u>Inclusive Economic Recovery Strategy</u> (IERS). Through the May budget revise and AB 129, SCAG was awarded \$3.5 million in one-time grant funding to implement several core recommendations in the IERS that is centered around work products in five areas: 1) Supporting expansion of the number of, and access to, middle wage jobs; 2) Strengthening supply chains and access to contracting opportunities; 3) Construction apprenticeships and training; 4) Providing regional data; and 5) Addressing human capital needs. The grant funding is being implemented through an agreement with the California Workforce Development Board and work is slated to begin in early 2022.

MEET-AND-GREET WITH NEWLY ELECTED ASSEMBLYMEMBER ISAAC BRYAN

On Aug. 12, SCAG's executive board officers, including President Clint Lorimore, 2nd Vice President Carmen Ramirez, and Immediate Past President Rex Richardson, who were joined by Legislative/Communications and Membership Committee Chair Alan Wapner and Regional Council members Alex Fisch and Mark Henderson, met with Assemblymember Isaac Bryan (D-Baldwin Hills) who was recently elected to represent California's 54th Assembly District. Assemblymember Bryan previously served as an advisor to Senator Sydney Kamlager (D-Los Angeles) and Mayor Eric Garcetti. Assemblymember Bryan spoke with our board officers and Regional Council members about his commitment to solving the state's housing crisis. He also expressed that he shares other priorities with SCAG, such as good environmental good stewardship and increasing broadband access. As a newly elected Assemblymember, he expressed a desire to maintain dialogue and leverage SCAG's resources and knowledge to guide policy solutions.

GO HUMAN UPDATE

COMMUNITY STREETS MINI-GRANTS PROGRAM FUNDS 31 COMMUNITY-LED PROJECTS

In June, SCAG awarded over \$275,000 through the *Go Human* campaign to community organizations and non-profits to implement 31 targeted traffic safety engagement projects across the region as part of its Community Streets Mini-Grants Program. This third funding round awarded more resources than the previous two rounds combined (over \$41,000 was awarded to 14 projects in 2018 and over \$210,000 to 28 projects in 2020). Awardees have initiated engagement

strategies to increase safety of pedestrians, provide education on proper helmet fittings, implement temporary safety demonstrations, facilitate leadership training for youth and other community members, and implement digital outreach efforts, among many other creative, community-led strategies. Engagement strategies will continue through September 2021. Please visit the *Go Human* blog for more information about the awardees.

SUMMER TRAFFIC SAFETY PEER EXCHANGE SERIES COMES TO A CLOSE

In August, SCAG's *Go Human* campaign wrapped up its summer 12-part <u>Traffic Safety Peer Exchange</u> series. The virtual sessions kicked off in June and brought together more than 300 partners and practitioners from public agencies, non-profits, community-based organizations, and others throughout the region to share their experiences and insight on addressing the region's most pressing traffic safety issues. The June sessions addressed high-injury networks, safety funding, and community engagement while the July and August sessions addressed traffic safety issues confronting rural, suburban, and urban communities. The sessions featured speakers from community-based organizations such as <u>The Center for Community Action and Environmental Justice</u> and the <u>Central Coast Alliance for a Sustainable Economy</u>, government organizations such as <u>Riverside University Health System</u> and the <u>City of Ventura</u>, and state and elected officials such as California Transportation Commissioner Michele Martinez and City of Redlands Councilmember Denise Davis. 'ACTIVATE ARTESIA' SAFETY DEMONSTRATION PROJECT HELD IN LONG BEACH

On Aug. 21, in partnership with the City of Long Beach, SCAG's *Go Human* campaign hosted **Activate Artesia Blvd** *(a)* **the Uptown Jazz Festival**. The event featured a *Go Human* demonstration project highlighting proposed safety improvements including curb extensions, high visibility crosswalks, and a parklet on Artesia Blvd. The project highlighted upcoming improvements as part of the Artesia Grand Boulevard project led by Long Beach Public Works. The event also featured many local vendors and interactive programming including a health equity fair led by the Black Health Equity Collaborative, the "Hoop Bus" promoting local parks and recreation, music and entertainment by the Urban Society, popups from local restaurants, and a Kids Zone sponsored by the YMCA. The event drew more than 250 participants and 75 survey responses.

FHWA-SUPPORTED TRANSPORTATION SAFETY MODELING WORK

At the July 2021 Modeling Taskforce meeting, SCAG shared details from its recent work developing predictive models for safety planning and target setting. SCAG initiated this work last fall after securing support from the Federal Highway Administration (FHWA) through their Safety Data and Technical Assistance Program. The two distinct suites of models include safety target setting models that predict fatalities, serious injuries, and non-motorized fatalities and serious injuries at the county level. The work also resulted in the development of community models that predict traffic crashes at the traffic analysis zone level. The safety models will support SCAG's work going forward as the agency establishes safety targets to comply with federal legislative requirements. The models will help the region estimate how much investment in safety may be needed to meet future safety targets given growth and other regional changes. The safety models can also support assessments of the safety impacts of large-scale projects and the comparisons of alternative growth scenarios (i.e., scenario planning). SCAG staff anticipate wrapping up this work in September, after receiving final feedback from Caltrans as well as the Office of Traffic Safety.

STATEWIDE GUIDANCE ON HIGH INJURY NETWORKS

In July and August, SCAG held Listening Sessions and shared presentations with stakeholders regarding highlights from a new draft of the "Recommendations for Statewide Guidance on High Injury Networks" report. Since November 2020, a statewide team pulled from California's Strategic Highway Safety Plan (SHSP) Bicycle and Pedestrian Challenge Teams, which was led by SCAG staff, have been working on recommendations for high injury network (HIN) statewide guidance.

Much of the work involved drafting a report that reviewed existing HINs across California, assessed case studies, discussed challenges, and provided resulting recommendations for statewide and jurisdictional guidance. SCAG staff are currently in the process of integrating stakeholder feedback and anticipate sharing the final report with the SHSP Steering Committee and Caltrans in September. The ultimate goal is to have the guidance institutionalized in the "California Manual for Setting Speed Limits" so jurisdictions with HINs can have more authority over setting speeds at the local level.

SB 743 LOCAL IMPLEMENTATION ASSISTANCE

SCAG has been collaborating with several local agencies throughout the region in the development of locally focused implementation plans in support of SB 743-related vehicle miles traveled (VMT) assessment and mitigation requirements. SB 743 changed the focus of California Environmental Quality Act (CEQA) transportation impact analysis from motor vehicle delay, as measured by "level of service" (LOS), to VMT reduction. Local implementing agencies are now required to assess and, if necessary, mitigate the level of new VMT that would be generated by new development projects as part of the CEQA process. SCAG is currently working with the Los Angeles Department of Transportation (LADOT), San Bernardino County Transportation Authority (SBCTA), and City of Banning on SB 743 implementation programs specific to their jurisdictions. Three of the four current projects are supported by the SCAG Sustainable Communities Grant program: LADOT (Phase 1), SBCTA, and City of Banning. The fourth of these projects, LADOT (Phase 2), is being funded through a Caltrans Sustainable Transportation Planning grant. Two additional SCAG-supported SB 743 local implementation assistance projects, for the City of Temecula and Western Riverside Council of Governments, have been completed.

SCAG TEAM TO PROVIDE TECHNICAL ASSISTANCE WITH SB 379 SAFETY ELEMENT UPDATES

From February to June 2021, SCAG's Local Information Services Team (LIST) provided Housing Element technical assistance to more than 70 local jurisdictions and stakeholders in the SCAG region. Responding to jurisdictions' requests for further technical assistance, a team of technical staff is prepared to provide one-on-one technical and information services. Currently, the LIST members are focusing on assisting local jurisdictions with Safety Element updates, specifically the component under SB 379 that requires cities and counties to include climate adaptation and resilience strategies into their next Safety Element update. LIST members are providing technical assistance services on SCAG's available climate adaptation data and tools, such as toolkits from the Regional Climate Adaptation Framework, environmentally-sensitive layers within HELPR 2.0, and the recently published "SB 379 Compliance Curriculum for Local Jurisdictions." SCAG RECEIVES APA AWARD FOR CLIMATE ADAPTATION PLANNING TOOLS

On July 17, the American Planning Association's Sustainable Communities Division (APA-SCD) awarded SCAG their 2021 Award for Excellence in Sustainability: Policy, Law, or Tool for its work on the Southern California Regional Climate Adaptation Framework (CAF). The APA-SCD Award for Excellence in Sustainability honors projects, policies, plans, individuals, and organizations whose work is dedicated to supporting sustainable, resilience, and equitable communities. The Southern California Regional Climate Adaptation Framework consists of a collection of adaptation planning tools and resources ready for use by jurisdictions to help individuals, communities, and natural systems cope with the unavoidable consequences of a changing climate. Background

SCAG

The SCAG region is complex and growing, facing unprecedented challenges like climate change, a housing crisis, and rising inequity. As the largest Metropolitan Planning Organization in the country, SCAG recognizes that addressing these big challenges must happen collectively and from the ground up under a common vision to move the region forward.

The well-being of the region is intimately tied to the ability of local jurisdictions to plan for their own futures, and share those plans with SCAG in the form of land use and other data. In other words, Connect SoCal – the region's long range vision plan for 2020-2045- cannot be realized unless Local General Plans are actively updated and driving change at the local level.

However, a significant portion of local jurisdictions in the region are struggling to update their General Plans on a regular basis because they lack in-house resources, technology, and skillsets. A 2018 region-wide survey found that:

- 70% of local agencies lacked technical staff to analyze data
- 43% had no in-house GIS support
- 84% shared data through email or other means of direct communication, putting personal information at a security risk

The Regional Data Platform (RDP) aims to change this. The RDP is a "rising tide that lifts all boats"- leveling the playing field by enabling all member agencies, regardless of size and technological maturity, with modern planning tools, technology, standardized data, and best practices to support robust and timely General Plan updates.

What is the Regional Data Platform?

SCAG's RDP is a revolutionary system for collaborative data sharing and planning, designed to facilitate better planning at all levels; from cities and counties of all sizes all the way up to the region as a whole.

The RDP is a signature element of SCAG's Future Communities Initiative - a work program adopted to accelerate SCAG's leadership in technology and big/open data to promote a smarter and more connected region. As one of SCAG's largest and most transformative projects to-date, the RDP focuses on using data to help solve our common challenges.

CONSTRUCTION

1. I-8/Imperial Avenue Interchange: The project includes installing two ramps that will provide direct access to southbound Imperial Avenue which will provide connectivity to southern El Centro. Work will take place weekdays over regular and extended day shifts for the next two months. Westbound I-8/ Imperial Avenue ramps are expected to be reopened late fall 2021. The El Centro City community identifier is being fabricated and is estimated to be installed in November.



The bridge deck pour was completed in late August and concludes the major concrete work. The project is expected to open to traffic in late 2021 or early 2022, with plant establishment/close out work continuing through 2023.

- 2. SR-98 Widening Project: As part of the Calexico West POE Expansion project, SR-98 and Cesar Chavez Boulevard were widened and improved to serve the expansion to the west. SR-98 work between VV Williams and Ollie Avenue was completed in March 2018, and the Cesar Chavez Blvd. widening was completed in October 2019 by the City of Calexico. Construction for the SR-98 widening between Rockwood Avenue and Ollie Avenue began in mid-August. The project is expected to be substantially completed and open to traffic in late 2022. The total project cost is estimated at \$8.2 million.
- 3. **SR-111 Niland Geyser/Mud Pot:** The SR-111 Niland Geyser/Mud Pot is active. The caldera has moved and is now 15 feet from the SR-111 edge of travel way. Water from the Mud Pot continues free-flowing through the subsurface drainage installed in 2019. The original temporary detour road was opened to traffic in August of 2020. Due to the Mud Pot's unpredictable change in direction, a revised detour was required. The revised detour was completed on April 30, 2021. The detour will remain in place as the mud pot moves beyond the original freeway.

PROJECT DELIVERY

1. **SR-186 All-American Canal Bridge:** This project proposes to construct a new bridge over the All-American Canal (AAC). The new bridge will improve safety and better facilitate international and interregional movement of people, goods and services. A 2019 feasibility study proposed 8 alternatives including a no-build option. The following stakeholders have been identified, Fort Yuma Quechan Indian Tribe, US BIA, US BOR, IID, International Boundary and Water Commission, County of Imperial, Union Pacific Railroad and US GSA. Project Milestones: Project Approval/Environmental Clearance 9/2023. The Anticipated funding fiscal year for construction is 2025/26.

MAINTENANCE AND TRAFFIC OPERATIONS

- 3. El Centro Functional/Landscape Sign/landscape maintenance, sign installation orders at various locations, chemical control-SR-86.
- 4. Brawley Travelway Crew Guardrail repair-SR-86, drainage inspection SR-86, brush control-SR-78. Coastal cleanup event, disposal of unwanted items from public on September 18th.



5. **SR-86/Customs & Border Protection Checkpoint Expansion:** ICTC received confirmation from Customs & Border Protection (CBP) HQ that they will move forward with the original canopy design similar to the I-8 Pine Valley checkpoint. Caltrans has received the 65% plans for circulation from ICTC and their consultant, AECOM. The environmental studies are being prepared by AECOM and will soon be sent for review. Caltrans will assist ICTC in coordinating upcoming meetings.

An environmental document as well all other appropriate studies will be needed to finalize the project. A series of permits will be required for existing traffic control at the checkpoint, for the inspection operations and equipment within the facility, and for a temporary checkpoint while the project is in construction. A new Freeway Maintenance Agreement will be required for the portion of the existing canopy that is within Caltrans ROW.

PLANNING AND LOCAL ASSISTANCE

1. District 11 Active Transportation Plan: Caltrans District 11 is still soliciting input from the public and partners outreach efforts for the Caltrans Active Transportation Plan (CAT Plan). The surveys will close at the end of October followed by an evaluation and creation of a needs list. QR code decals have been placed on sidewalks throughout San Diego and Imperial County. Scanning the code with a smart phone will take the user to the on-line survey. The District 11 CAT Plan is scheduled for completion in summer 2022.

2. **Project Study Report: Forrester Road Improvements** Traffic increases on Forrester Road (I-8 to the City of Westmorland) have led to longer travel times and limited passing opportunities. Caltrans and ICTC are preparing a PSR that is spearheaded by a Technical Working Group (TWG) that includes the County of Imperial, the Imperial Irrigation District (IID), and the cities of El Centro, Westmorland, Imperial, and Brawley. The TWG met in late July and proposed improvements that include shoulder widening, passing lanes, intersection improvements, a bypass to the city of Westmorland and a 4-lane expressway.

3. Local Assistance:

October 7, 2021 – "Clean California" Local Grant Program Workshop (online)

The California Department of Transportation (Caltrans) will administer approximately \$296 million as part of a two-year program to improve and beautify rights-of-way, tribal lands, parks, pathways, and transit centers to restore pride in public spaces. Applicants must be local, regional or tribal governments or public transit agencies. Nonprofit organizations may be subapplicants.

A call for projects is anticipated in December 2021 with the application deadline expected in February 2022.



EMPLOYMENT AGREEMENT IMPERIAL COUNTY TRANSPORTATION COMMISSION EXECUTIVE DIRECTOR

THIS EMPLOYMENT AGREEMENT is made and entered into this July 24, 2019 by and between the Imperial County Transportation Commission ("ICTC"), a public entity, and Mark Baza ("Baza"), an individual.

WITNESSETH:

WHEREAS, ICTC was established under and is governed by Division 12.8, commencing with Section 132800, of the California Public Utilities Code and other statutes relating to transportation commissions; and

WHEREAS, the Executive Director is the chief executive officer of ICTC and serves at the pleasure of the Board of Commissioners ("Board") of ICTC; and

WHEREAS, the Board finds that Baza possesses the knowledge, skills and experience to act as the Executive Director of ICTC; and

WHEREAS, Baza has agreed to continue to act as ICTC Executive Director.

NOW, THEREFORE, it is agreed as follows:

Section 1. Services.

Baza agrees to perform the following services as Executive Director of ICTC:

- A. The Executive Director serves as the chief executive officer of ICTC and takes direction from the Board. The Executive Director manages the daily operations of ICTC, implements and monitors Board policy, and coordinates the activities of the ICTC on behalf of the Board. Baza shall have full executive authority to perform all duties, services, and actions necessary or advisable to carry out the policies of ICTC and the needs of ICTC and the Board. Baza shall diligently attend to the business of ICTC, including attendance at meetings and proper supervision of those individuals who report directly to the Executive Director. Baza shall provide the services in accordance with all applicable laws, regulations, ICTC Bylaws, and other policies adopted by the Board.
- B. The Executive Director shall perform all the duties described on the job description attached hereto as **Exhibit "A"** and incorporated herein.

Section 2. Compensation.

- A. In consideration of the performance of Executive Director, ICTC agrees to pay Baza as detailed below effective the first full pay period following July 1, 2019. Baza shall continue to receive payments in the same amount as he currently receives under his current contract with ICTC until payments under this contract begin.
 - 1. A salary of one hundred fifty six thousand dollars (\$156,000) annually. This position is an FLSA exempt, managerial, position that is not entitled to overtime pay.
 - 2. Additionally, ICTC shall pay to the Executive Director a monthly car allowance of eight hundred dollars (\$800).
 - 3. ICTC shall pay all holidays, sick leave, vacation and administrative leave as that paid to ICTC employees as defined in the Personnel Policy and Procedures for ICTC. Baza shall receive all benefits normally provided to ICTC employees except for health.
 - 4. In the event of termination of this Agreement by the Board, Baza may receive severance pay as detailed in Section 5 of this Agreement.
- B. Reimbursement: ICTC shall reimburse all reasonable and necessary travel and educational expenses for attending seminars and conferences representing ICTC as its Executive Director at meetings shall be reimbursed by ICTC.
- C. Status with ICERS: The Board and Baza will retain retirement membership services under the 1937 Retirement Act through the Imperial County Employees' Retirement System (ICERS). Baza and Board will make contributions consistent with the requirements of ICERS for employees and employees.
- D. Except as provided under Paragraph A, ICTC shall not be responsible to pay Baza any compensation, out-of-pocket expenses, fees, or other remuneration.

Section 3. Review.

On an annual basis the Board shall identify a focused set of priority objectives for the organization and Baza. The Board will review the performance of the Executive Director annually. At the Board's option, a merit increase in salary of up to five percent (5%) may be considered upon each annual review.

- A. Prior to the Evaluation. Prior to the beginning of each performance evaluation cycle, Baza shall prepare a summary of the current year priority objectives, goals and accomplishments for review by the Board.
- B. Contents of the Evaluation. Employee shall be evaluated on effective management and the progress made on the Board's annual priorities, among other factors determined by the Board.
- D. Amendments and Changes to Evaluation Process. The Board may amend or change the evaluation process as needed provided that such changes will take place at the beginning of the next evaluation period.

Section 4. Term.

This Agreement shall commence July 1, 2019, and remain in effect for one (1) year.

Section 5. Termination.

- A. Either party may terminate this Agreement, without cause and without notice.
- B. <u>Severance Pay</u>. In the event the Board terminates Baza prior to the expiration of the employment agreement, Baza shall be entitled to severance pay as set forth below.
 - 1. If there are six (6) or more months remaining in the employment Agreement, Baza shall be entitled to an amount equal to six (6) months salary.
 - 2. If there are less than six (6) months remaining in the employment Agreement, Baza shall be entitled to an amount equal to the exact number of months remaining in the Agreement. For example, if Board terminates Baza with only two and one-half (2.5) months remaining in this Agreement, Baza shall receive two and one-half (2.5) months of severance pay.
 - 3. In the event Baza receives any severance pay, the amount shall be paid to Baza in monthly installments and shall not be paid in one lump sum. Such monthly installments shall be equivalent to the amount of Baza's regular monthly salary until the severance amount owed is exhausted.
 - 4. There shall be no severance pay if Baza elects to terminate his contract with Board.

- C. Upon termination of this Agreement, Baza shall immediately turn over to ICTC any and all copies of studies, reports, or analyses, whether or not completed, prepared by him in connection with this Agreement. Such materials shall become the permanent property of ICTC.
- D. <u>Termination for Cause</u>. In the event Baza is terminated For Cause, Baza will not be entitled to severance pay. However, ICTC shall pay Baza all wages owed through the date of termination For Cause as well as any accrued but unused vacation time in accordance with applicable local, state and federal law. Accrued but unused sick leave and administrative leave benefits are not paid upon termination For Cause. The precondition of termination For Cause is met if one or more of the following defined instances exists:
 - 1. Baza is convicted of a felony or a crime involving moral turpitude;
 - 2. Baza makes an intentional and material act of dishonesty, misappropriation, embezzlement, intentional fraud, or similar conduct while acting within the scope of employment;
 - 3. Baza's willful or grossly negligent conduct results in material damage to ICTC property;
 - 4. Baza makes threats of violence or acts of violence in the workplace;
 - 5. Baza engages in conduct found to constitute illegal harassment, discrimination or retaliation of another employee, consultant, member representative or staff, client, customer, or independent contractor;
 - 6. Baza is unable to perform the essential functions of his position with or without reasonable accommodations due to a disability in conformity with applicable local, state and federal law;
 - 7. Baza's gross negligence or intentional and willful refusal to follow the reasonable and lawful directions of the Board that Baza fails to cure within fifteen (15) business days of receiving written notice from the Board;
 - 8. Baza's material non-performance or breach of this Agreement, violation of ICTC policy, or any other statutory duty owed by Baza to ICTC that Baza does not cure within fifteen (15) business days after Baza's receipt of written notice thereof from the Board (provided such violation is capable of cure).

Section 6. Representations

- A. Baza represents and warrants that the subject services shall be performed exclusively by him.
- B. Baza represents and warrants that all reports, analyses, grant applications or other

documents developed under this Agreement shall become the exclusive property of ICTC.

Section 7. Indemnification

- A. Except as provided below, ICTC shall indemnify and hold harmless Baza from any and all claims, liabilities, losses, damages, and expenses, including reasonable attorneys' fees, as a result of acts that Baza performed in the course and within the scope of his employment.
- B. ICTC's obligation shall not apply in the event that claims, liabilities, losses, damages or expenses, including reasonable attorneys, fees, are incurred as a result of Baza's acts which are intentional, grossly negligent, or undertaken outside of the course and scope of employment. ICTC's obligation shall not apply in the event that claims, liabilities, losses, damages or expenses, including reasonable attorney's fees, are incurred as a result of Baza's failure to promptly notify ICTC of any claim made or litigation filed against him; or he has settled or compromised the claim or litigation as to him without the ICTC's prior written consent.
- C. Baza shall, as a condition precedent to receipt of such indemnification, cooperate with ICTC and its legal counsel in the defense of any related action, claim or proceeding. ICTC will otherwise defend Baza with its own legal counsel and shall include the payment of his reasonable attorneys' fees only in the event ICTC requires Baza to retain separate counsel. Should Baza retain separate counsel not suitable to ICTC or upon his own initiative without being required to do so by ICTC, ICTC shall have no obligation to pay Baza's attorneys fees or costs.

Section 8. Insurance.

- A. At Baza's sole cost and expense, he shall obtain, and keep in force at all times during this Agreement, a policy of automobile liability insurance for any automobile that he may use in connection with his duties, or traveling to conferences or meetings, with coverage that is acceptable to the Board.
- B. ICTC shall maintain Workers' Compensation coverage and any other insurance that is required under California law, for all employees, including Baza.

Section 9. Licenses and Permits.

Baza represents and warrants that he possesses all required licenses to perform all aspects of this Agreement, such as a valid Driver's License.

Section 10. Modification.

No modification, waiver, amendment, discharge, or change of this Agreement shall be valid unless it is in writing and signed by both parties.

Section 11. Severance.

In the event that any provision is adjudged or decreed to be invalid, such ruling shall not invalidate the entire Agreement but shall pertain only to the provision in question and the remaining provisions shall continue to be valid, binding, and in full force and effect.

Section 12. Non-Assignment.

Baza shall not assign, transfer or subcontract this Agreement nor his rights or duties under this Agreement, without the prior written consent of the Board. Any attempt by him to assign or otherwise transfer any interest in this Agreement without obtaining the prior written consent of the Board is void.

Section 13. Force Majeure.

Baza shall not be held responsible for delays in performing services as a result of acts beyond his control and without his fault or negligence, including, but not limited to, acts of God or public enemies, acts of state or local governments or public agencies, utility or telecommunication delays or failures, accidents not resulting from his negligence, fire, flood, storms, epidemics, strikes, lockouts, industrial disturbances, war, rebellion or civil strife.

Section 14. Notices.

All notices and communications deemed by either party to be necessary or desirable are to be in writing and given to the other party by personal delivery or sent through the U.S. mail, first class with prepaid postage, addressed as follows:

Section 15. Governing Law and Venue.

- A. The rights and obligations of the parties and all interpretation and performance of this Agreement shall be governed in all respects by the laws of the State of California.
- B. To the extent permitted by law, any action brought by either party with respect to this Agreement shall be brought in a court of competent jurisdiction within Imperial County.

Section 16. Entire Agreement.

This Agreement constitutes the entire agreement between Baza and ICTC with respect to the subject matter hereof and supersedes all previous negotiations, proposals, commitments, writings, advertisements, publications, and understanding of any nature whatsoever unless expressly included in this Agreement.

Section 17. Counterparts

This Agreement may be executed in counterparts and by facsimile.

Section 18. Review of Agreement Terms

This Agreement has been reviewed by legal counsel for ICTC and Baza has been afforded an opportunity to have this Agreement reviewed by legal counsel, and no presumption or rule that ambiguities shall be construed against the drafting party shall apply to the interpretation or enforcement of the same or any subsequent amendments.

The Southern California Regional Energy Network (SoCalREN) brings together a wide variety of services with one common goal: achieving unprecedented levels of energy savings throughout Southern California. Authorized in 2012 by the California Public Utilities Commission (CPUC), the SoCalREN provides services to residents, businesses, and public agencies throughout the areas served by Southern California Edison (SCE) and/or SoCalGas. The SoCalREN Advisory Committee is currently made up of 15 local government representatives from different geographic regions of SoCalREN's diverse twelve-county territory. Dear Commission Members:

In accordance with the provisions of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU), recipients under the Federal Transit Administration (FTA) Sections 5310 amongst other federal programs. Public transit agencies must comply with all federal coordinated planning requirements to be eligible for available funds. The reauthorization stipulates that project selected for funding under these specified programs must be derived from a locally coordinated, public transit-human services transportation plan (Coordinated Plan).

The update to the Coordinated Plan includes a reassessment of all available public and private transportation services in Imperial County, a reassessment of public and social services transportation needs, development of strategies and/or activities to address gaps in service, identification of coordination actions to eliminate or reduce duplication in services where they exist, and a prioritization of implementation strategies. The plan also provides numerous findings and recommendations for project implementation.

In September 2020, ICTC hired the consultant team from *Moore and Associates* to develop a Coordinated Plan for the Imperial County. The team from *Moore and Associates* conducted multiple public workshops throughout the Imperial County, conducted rider surveys and digital surveys to obtain public feedback. The project generated extensive feedback despite the limitations imposed by the pandemic.

The Draft Plan inclusive of the findings and recommendations will also be presented to the Social Services Transportation Advisory Council.
